



TERMS AND CONDITIONS 20% Credit Bonus (“Promotion”)

1. By making a deposit to your RockfortMarkets Limited (“Rockfort”) MT4 Account under this Promotion (“Promotion”), you acknowledge you have received, read, and agree to be bound by these Terms & Conditions and the Client Agreement available on the Rockfort website.
2. The promoter, Rockfort Markets Limited, Level 2, 22 Fanshawe Street, Auckland 1010 is incorporated in New Zealand (FSP509766) and registered by the Financial Services Authority (“Promoter”). To contact the Promoter, please email info@rockfortmarkets.com.
3. Defined terms have the same meaning as the Client Agreement unless otherwise specified in these Terms & Conditions.
4. This Promotion is available to qualifying Clients identified in clause 5 and not excluded by clause 6, 9 or 12.
5. To be eligible for the 20% Credit Bonus Promotion, you must meet both a) and b) below on an eligible Rockfort account by 11:59pm NZT on the 31st December 2020 (“the Offer Period”):
 - a. Make the Minimum Deposit – this means making a deposit of at least \$200 USD to your MT4 account (or see Table 1.1 for other account base currencies); and
 - b. Make at least one trade before 11:59pm NZT on the 15th January 2021 (“the Offer”).
6. New and Existing Clients can participate.
